4. NASEA ANMA Convention 2013

a. 2012 balance sheet - Gobinda Shrestha

ANMA has sent a summarized sheet of the balance. There is supposed to be an itemized one that they said they will be sent but we haven't received it yet. We owe \$2,700 out of which \$1,200 has been raised and sent to them, we still owe them \$1,500. Since this cannot be taken from the NASEA funds directly we need to have a surplus in 2013 and pay it from the surplus or by fundraising. We don't have the power to take the money from the NASEA account since those funds are meant for their own special purpose.

ANMA President Gopendra ji joined the conference -

Janak Baral - We haven't received the itemized, let's go through that and we can come to the decision once we can go through that.

Sanjeeb Sapkota - We are accountable to General Assembly. Therefore we need to move forward with way to pay the \$1,500 and also come with an itemized list for a way to justify the payment.

There needs to be a close collaboration between the Presidents and Treasurer of both organizations.

I - Gobinda Shrestha - Ask items that will be needed to justify the payment to NAsEA from the ANMA board.

II - Sanjeeb Sapkota - We will try to raise \$1,500 and try to send it within 45 days.

III - There was a meeting to decide on the finances of 2009 and 2011 convention held by NAsEA. 2009 deficit in NAsEA Convention and the 2011 surplus in NAsEA Convention balanced out so this was closed out. (ANMA member - Rajendra Khatiwada NAsEA Member - Raja Ghale, Sanjeeb Sapkota, Ram Dongol)

b. Memorandum of Understanding - Dr. Ram Baral
