#### Highlights of the First International Convention of Nepalese Associations

#### INTRODUCTION

With many years of adoration and networking, Nepalese Associations from around the world jointly launched a convention at Atlanta, Georgia, USA, on July 1-3, 2000 (Atlanta Marriott Century Center). The convention was the collective vision of many Nepalese Associations and friends of Nepal. The theme of this convention was "Nepalese Unity 2000". The primary goals of this convention were to share knowledge, expertise, and resources among the Nepalese living abroad so that we can bring positive changes that can benefit Nepal and Nepalese communities in which we are currently residing.

#### NASeA Education Assistance Program

In 1998 UNESCO reported the literacy rate in Nepal as 35.9%. It is even more disturbing and saddening to learn that the literacy rate for females is only 23.8%. This means one out of our four Nepalese sisters can not read or write. No prosperity and peace is possible in a country without basic education to the people. Some may view it as a national problem and we, as individuals, have nothing to do with this. If we care for our motherland, why NOT do something about this? As Nepalese living abroad, we love Nepal, our motherland, dearly. If we care for our country, we must do something about it. This may appear to be a formidable task, but with a little help (Haste Ma Hai) and desire from every member we can do it!

The Nepalese Association in Southeast America (NASeA), therefore, has established an **Education Assistance Program.** NASeA will act as a facilitator to those who are interested to help Nepalese in education. NASeA is very proud of those members who have been helping Nepal in education and would like to help more through NASeA.

#### **OBJECTIVES**

The main objectives of this program are to:

- Provide educational assistance to young Nepalese living in Nepal
- Provide educational materials to school libraries and laboratories in Nepal
- Facilitate educational exchange program between Nepal and the US

In general, we wish to achieve these goals by providing scholarships, educational materials, and through exchange programs. This program will initially focus at providing educational assistance to primary through high school students within Nepal. However, the program may be expanded in the future to include college students as well as students outside Nepal. (more on Page 3)

As we enter a new year of this millennium, I thank



a "Nepalese Unity 2000" proclamation.


#### POETRY FESTIVAL

The poetry festival was opened by a welcome speech by Dr. Bishwa Acharya. Dr. Shiv Raj Gautam and Mr. Bashanta Shrestha, Coordinators of the poetry festival conducted the program. These poems were evaluated by seven panel committee members. The panel was constituted by four poets from Nepal and three from the USA. Out of the hundred poems that were cited, the panel members chose the three most outstanding poems. The three outstanding poems were awarded certificates and checks of \$500, \$300, and \$200 respectively.

#### **OPENING CEREMONY**

the second day of the convention. The Chief Guest of the opening ceremony was the Right Honorable Former Prime Minister Sher Bahadur Deuba. The morning program started

To enhance social interactions among participants, several social activities such as yoga, meditation, bhajan, dances, and sports took place. Five soccer teams (Atlanta, Kansas, Alabama, North Carolina, and Washington DC) participated in the friendly competition. Although all of the soccer teams' performances were magnificent, Kansas team came up at the top and won the first prize. The sports was coordinated by Mr. Raja Ghale.

A Blood Drive was organized at the convention site by Dr. Bhaskar Dawadi. About 35 participants donated blood, and each donor received a T-shirt. Feed the Homeless was also organized by Mrs. Dibya Pradhan; sandwich lunch bags were served to more than 50 homeless people of downtown Atlanta.

#### **CULTURAL PROGRAMS**

The cultural program was the focal point of the convention and this was coordinated by Mr. Shaubhagya L. Shrestha. The program was presented by 100 different performers from various part of the world. The program provided opportunities to show different and distinct talents. On the stage, there were first time performers as well as professional performers. The ages of the performers ranged from 7 years to 70 years. The programs performed by children were much acclaimed by the

stand ups, and fashion shows. The cultural program symbolized every aspect of the Nepalese culture. The dances with Nepali songs represented Nepali national and modern songs, while the Hindi songs' dances represented bollywood's influence in Nepal. The Newari, Tamang selo, Bhote selo, and Lakhe dances informed audience of the diversity among the Nepalese culture. In addition to dances, songs were also performed. The songs that were sung with the help of a madal symbolized the uniqueness of Nepali music. The flute, violin, sitar, and Hawaiian guitar gave different flavor in the program. The skit performance on Romeo and Juliet was a unique and humorous presentation. The bands with modern equipment symbolized the modernization of Nepali music talents. Modernization (diversification) was also vivid in the fashion show through the display of western outfits. Daura surwal and saris costumes exhibited traditional wear of Nepal. The fashion show ended with displaying outfits worn in the wedding by bride and groom. The comedians informed the audience of notorious habits of Nepalese people. Mr. Chip Carter, President of Friendship Force International, also attended the abroad.

### RESOLUTIONS OF THE CONVENTION

The core of this convention was to create an environment based on our common beliefs and values, to pave a path for our future generation with some set of examples so that our future generation will have a focused but broad-based endeavor to preserve and enhance the Nepalese culture and heritage wherever they are residing. In order to achieve these goals, ten resolutions were ratified. The gist of these resolutions is as follows:

### The First International Convention of Nepalese Associations of 2000:

- 1) Supports human rights and democracy as a way of life in Nepal or anywhere else.
- **2)** Adopts non-violence as a means to world peace, which should be practiced by Nepalese in Nepal and abroad.
- 3) Supports equal opportunity for all regardless of age, gender, race, color, religion, or economic status for economic, political, or social benefit for all in Nepal or abroad

- 4) Opposes any social injustice such as caste system, bonded laborer, women trafficking, inhuman treatment of animals including animal sacrifice, as detrimental to the advancement of Nepalese society.
- 5) Realizes environmental issues are critical for the survival of humanity and therefore recommends that we individually seek to practice, show and teach others examples of good environmental practices.
- 6) Understands the importance of volunteerism and recommends to our community members of all ages to become involved in community services whatever communities they reside and by whatever means they can employ.
- 7) Supports all non-destructive research, and any endeavor to explore space and computer technologies. We also support technology transfer to improving quality of life worldwide.
- 8) Calls on all in the Nepalese community to protect, and disseminate our heritage, culture, and common interests of the Nepalese people throughout the world. For this, we shall support the on going cultural center project in Washington, D. C., and any other similar projects around the world.
- 9) Supports the idea of an international convention and recommends a standing committee be formed with the representatives from each known Nepalese Associations worldwide to establish the location date and agenda for the next convention.
- 10) Agrees to forming a World Nepalese Organization which will promote Nepalese culture, be a voice for human rights and democracy, and raise voice for common causes, i.e., act for the betterment of Nepalese community. The headquarters of this body will be decided accordingly, and a committee will be formed with a representation from different associations.

#### **CONCLUSIONS**

The concluding meeting of the convention was held on the morning of July 4, 2000 with representatives from six main organizations: ANA, ANMA, FNA, NCNC, NST, and NASeA. All unanimously expressed that the convention was a big success and decided to plan for such a meeting in the future. The finance committee presented an advance report on revenue and expense. The preliminary audit showed a deficit of approximately \$3,000.00 which is to be taken care by NASeA.
