\$49,373.42 is the current balance before the 2013 convention.

Life Membership fund: \$24,985, which accounts for 51% of our total funds. General Fund of \$18,801. Children's Fund: \$1000, Nepali School Fund, \$3,587, Education Fund: \$1,000.

Sushma - Question on the Treasurer

Saunak Ranjitkar - Question on whether the previous finances of the convention with ANMA has been settled.

Gobinda - We have cleared the financial matter with them. We have given them \$6,500, and also given them \$1,500

Ram ji Sharma - Can we invest this money?

Gobinda - We have as an executive member decided not to invest the money as we don't know if we are to bear profit or loss out of it. Currently its collecting interest in the bank. We have 34 new Life Members. He read the name of the life members. This list is available on our naseaonline.org website.

Prahlad Pant - Wanted to comment on why NASeA should invest the money. Due to inflation we will have less money, with average rate of 3%.

Narayan Rajbhandari - Due to non profit organization it might be legally impossible. Prahlad Pant - Currently running a non profit organization and its allowable.

Due to 44 members we don't have enough people.

Saunak - This is one of the biggest convention and we only have a third of the people needed to make the change, when are we ever going to have enough people to be able to change this.

Ajay Satyal - We need to change the rules to say what we need to do when we don't have the required 140 people.

Prahlad Pant - We need to discuss on what to do regarding the number.

Bimal Nepal- In coming executive body will have bylaws committee to introduce a vote.

Ram Baral - Let's keep current executive body member.

Samantha Thapa - We need to decrease the number otherwise there will never be a change in the bylaws.

Raja Ghale - We can do this! Just need more advertisement of this to the public.

Avi Malla - Let's put this in the ballot so that people can vote on this.

Sagun Shrestha - Let's wait until 2 years when the convention is back in NASeA's side so that we have enough members to pass the bylaws.

Narendra Baral - Let's put this out ahead so people know about this.

Tilak Shrestha - Let's do it electronic.

Tek Thapa - We have sent the email but it might not have reached everyone. 140 people is there so that its harder to make alterations so that we don't have frequent changes.

Let's not have other things going on at the same time so that we don't have people going to other places.

Madhav Mainali - This entire thing came out because we had a person for Treasurer coming from Chicago which is from ANMA side.

Ram Baral - Let the bylaws committee do their job and have no other sessions going on at the same time to increase members.

Sanjeeb - We had 3 motions and we received it before 7 days of the convention therefore we brought it forward to the General Assembly. New body for 2013-2015, will take the motions and keep working on it. Bylaws also state that we can have General Assembly any time if we have 30 signatures from the members. There is always room for improvement and the next body will take this motion into account.
